CEO: City's 'diamond in the rough' is shining brightly

Three years ago, in one of his first official appearances as Hoopeston Regional Health Center CEO, Harry Brockus told those attending the Community Awards Banquet that the health center was "a diamond in the rough."

Speaking Wednesday at this year's awards night, Brockus said that diamond "is starting to shine."

He highlighted several projects going on, including:

- A large financial investment in electronic medical records, using the same software as at Carle, that will allow HRHC to share patient records regionally. Records "can be transferred with you wherever you go," he said. "We're going to try to better coordinate your care."
- The 10,000 sq. ft. hospital addition, which will have new and bigger surgery suites, private rooms in the emergency room, a new trauma room, in- and out-patient recovery bays and, for youngsters, a train room, funded with money from East Central Illinois Model Railroaders' annual train show.
- The new nursing home, being built on Route 1 across from Anthem Chevrolet. The 75-bed facility will offer a new concept in elder care, allowing residents to make decisions about themselves and making the facility more homelike. "If an 84-year-old with diabetes wants chocolate cake, we'll find a way to make that happen," Brockus said. "If someone who's had a heart attack and is on a low-salt diet wants more salt, we'll make it happen. It's time to start telling our population it's ok to get old."
- The walk-in clinic, which is seeing 375 patients a month, without an appointment.
- The addition of dental services, coming in 2013 when Jonathan Smiley graduates and will oversee \$1

million dental clinic. Smiley will be one of the few dentists in the area who will accept Medicare and Medicaid.

- New cardiologists who will practice at Hoopeston Community Memorial Hospital and new cardio nuclear medicine, starting in March, along with stress tests done locally.
- The upcoming October merger between local medical offices, including the hospital, Charlotte Ann Russell Medical Center and clinics in Rossville and Cissna Park, with Carle Foundation. When the foundation takes ownership, Brockus, who is currently employed by Quorum Health Resources, will become employed by Carle.

Brockus also talked about the health center's partnerships with Hoopeston. "Things happen more quickly when we all work together," he said.

The largest recent partnership is the one between HRHC and the city to get a new water main installed at the site of the new nursing home.

In looking at the existing water main, "the old line is only 120 years old. What could possibly go wrong," Brockus joked.

HRCH officials, as well as those from Hoopeston and Vermilion Advantage, joined forces to get a **See DIAMOND on other side**

Some lawmakers seek 'marriage equality'

Six months after Illinois' "civil union" legislation went into effect, forces committed to redefining natural marriage are already planning their next steps.
